FEES:

Initiation Fee: \$50.00. \$25.00 deposit due when application is submitted; the \$25.00 balance due within 90 days. Monthly dues of \$20.00 is required when the applicant submits their application. Each month thereafter the applicant will pay monthly dues of \$ 20.00.

All categories of Membership are \$ 20.00 per month

Conditions of application for membership:

1. Applicant will enter the membership as a Probationary Member upon submitting the membership application form with all necessary fees and acceptance by the General Membership.
2. The Probationary Member will be reviewed by the General Membership after three (3) months for upgrade to an Associate Membership. During this probationary period, the applicant must attend six (6) meetings, which may be a combination of workdays, and/or general meetings. Dues must be current.
3. Due to the public nature of the Heritage Park, our insurance requires that Probationary Members submit to a no-cost background check before advancement to Associate Member. Ask a CMRS officer for details.
4. The Associate Member will be reviewed by the General Membership after an additional three (3) months for upgrade to Regular Membership. Also at this time new members will be required to purchase an official CMRS polo shirt with personalized name. The cost is approximately \$28 each, subject to manufacturer pricing.
5. Upon receiving Regular Membership status, the member will receive door and alarm codes.
6. Initiation Fee: \$50.00. A \$25.00 deposit is due when the application is submitted; the balance is due within 90 days upon acceptance into the CMRS as an Associate Member.
7. All application fees and dues paid during the application process become the property of the CMRS.

It is expected that each applicant will conduct themselves in a cooperative and harmonious manner in regard to all other members, and that they will cooperate in operating the model railroad in a prototype fashion, insofar as is possible, and that they will treat the equipment of other members and the club and its members & guests with proper consideration.
